



**Announcement of Phanomphrai Police Station**  
**Anti-Bribery Policy and No Gift Policy for the Fiscal Year 2025**

According to the Constitutional Act on Prevention . and Suppression of Corruption , B.E. 2561, Section 128 , Paragraph 1 stipulates: It is forbidden for any government official to receive any property or any other benefit that may be calculated as money from anyone other than property or benefits that are due to be in accordance with the law . Rules or regulations issued by virtue of the provisions of the law, except for the receipt of property or any other benefits by virtue of the rules and the amount of The NCPO... Commission stipulates and and codes of ethics for police officers B.E.. 2564 (2021), Clause 2(2) Honesty and Integrity behave Duties according to the law , regulations and regulations of the Royal Thai Police Office with transparency and do not express behavior that implies Abuse and responsibility for human rights duties are ready. Accept inspection and responsibility , have a good conscience, consider society , and point 2(4 ) think about the common good rather than personal interests, have a public spirit, cooperate , and work together ommon good and creating for the benefit of society . Prevention and Suppression of Corruption and Conduct Illegal (Revised ) Define Major Reform Activities Activity 4 Develop the Thai Bureaucracy to be Transparent and Non-Profit-Free Goal 1 Item 1.1. All units are declared as agencies where all government officials do not accept gifts and gifts of any kind from the performance of their duties (No Gift Policy).

Therefore, in order to prevent conflicts between personal and public interests , bribery, gifts , gifts, or any other benefits that affect the performance of duties, guidelines are prescribed. Anti-Bribery Policy and No Gift Policy for Gifts, Gifts or Any Other Benefits from the Performance of Duties , with the following details :

Article 1 : This Notice

"Supervisor" means a person who has the authority and duty todirect ,supervise, monitor and inspect police officers under his subordinate offices.

"Bribe" means any property or other benefit given to a person to incentivize that person to act. Commit any act in office , whether it is lawful or unjustified.

/Performance of duties

"Performance of duties" means the act or performance of duties of a public officer in a position appointed or assigned to perform any of the duties or to act on behalf of the public in any of the duties, both in general and specifically as a police officer whose powers and duties are prescribed by law or are acts in accordance with the powers and duties specified by law to have the authority and duties of the police.

"Gifts , gifts , or any other benefits that affect the performance of duties" means money, property, Any other valuable services or benefits provided including tips received by government officials in addition to salaries, incomes and government benefits in ordinary circumstances and affecting the decision , approval , permission or any other way to perform their duties. It is in a manner that favors fraudulently the giver of the gift either in the past or at the time of receipt or in the future.

Article 2 : Police officers at all levels shall behave as follows:

1. Do not ask for guidance or do not give or accept bribes , gifts , gifts or any other benefits from the performance of duties.
2. Do not consent or knowingly allow family members to give or accept bribes.gifts or any other benefits to related persons. In the performance of their duties.
3. The performance of duties must be based on the enforcement of the law with fairness,based on the interests and image of the The police must not take any action that is a conflict between personal interests and public interests, such as accepting gifts or any other benefits that affect the performance of their duties, using government resources for personal gain, disclosing inside information, obstructing official time for special work, etc.
4. Reduce the giving or receipt of property or any other benefits in accordance with the rules and amounts prescribed by the ..NCPO. Office . How to express yourself by signing a greeting card , a condolence card book, or using social media instead of giving things away.
5. Do not tolerate , do not tolerate , or be indifferent to the behavior of accepting bribes , gifts , gifts or any other benefits from the performance of duties . Violations shall be notified to the Superintendent/Station Head as soon as possible.

Article 3 : The supervisor shall have the authority and duty to supervise , monitor and inspect the police officers under his or her control. In case of any violation of this Notice, report to the Superintendent/Station Head as soon as possible.

Article 4 : Anyone who finds any violation of this Notification can lodge/whistleblower directly through the Superintendent of the Provincial Police Station at the Provincial Police Station or

Article 5 : Personnel under the affiliation who committed the offense at the Phanom Phrai Provincial Police Station will conduct a fact-check. And if an offense is found, the perpetrator will be punished according to the law. Strictly follow the relevant rules and regulations and continue to submit matters according to the hierarchy of command.
